Worship

Report from Jim Fox, Chairman of the Pastoral Search Committee (PSC)

Update from the committee was shared via email as follows:

- The candidate we were interviewing this time last month did not work out; summary is, despite being highly qualified, he had some exceptions to the Westminster Confession that were a concern. After discussing with Ron DiNunzio, we all agreed to pass on this candidate.
- We have 2 other applicants we are very interested in. We have one lined up for an interview next week and are in the process of scheduling a date to interview the other one.
- At this point, we are not ready to throw in the towel and look to hire a search firm. If neither of these 2 candidates pans out, we may need to go that route.
- Greg Baxter had raised the question of a bi-vocational pastor. My thoughts are, unless the finances are in dire straights, the PSC will continue to look for a full-time pastor. If our finances are indeed too low to pay a full-time salary, please let me know as that might change our approach. Otherwise we're looking for someone who will, with our help, grow the church body and thus help pay for himself. Given the population in our area and the strength and growth of other local churches, there should be plenty of opportunity for Fairview to return to growth.

Discussion by Session indicates that we are in favor of targeting a full-time pastor, not focus on a bi-vocational pastor.

Article // "<u>The Dilemma of a Bi-vocational Pastor</u>" author Darryl Williams – Elder Baxter & All

It was noted that the author of this article is speaking from a voice of experience as he is a bi-vocational pastor. The article caught the attention of Elder Baxter because he was curious if our church was more attractive to someone looking for part time ministry. If "growth" is part of our mission, there is a feeling that a blended approach (traditional and contemporary) will likely be something FEPC may need to entertain.

Article // "<u>5 Characteristics of Effective Ministry Teams</u>" by Ann Michel (7.29.2015) – D. of Min. Lesher & All

D. of Min. Lesher is committed to providing thinking points as we grow in our leadership. This article spoke to several great characteristics, including, shared vision, distinct roles, constructive engagement, size and leadership.

Worship Attendance Chart // January through 3rd Sunday of May - D. of Min. & All

The initial weeks in May show an increase in membership percentage that is in attendance. There is an expectation that the summer months tend to trend with lower attendance numbers, so we expect to see that in the near future.

Communion at Women's Retreat – Carolyn Thompson

Carolyn Thompson verified that Rev. Juliana Lesher is eligible to administer communion since active session members Elder Gyrath and Elder Adler will be present. Communion will be administered by cup and broken bread. Currently there are 41 women registered for the retreat.

Report from the Board of Trustees – Elder Adler

Board of Trustees Meeting Minutes

New gutters out front were installed incorrectly so that repair is being set up. The hot water heater has been fixed. Treads on stairs to basement have been repaired. The Pastor's Office has been painted and the cracked desk glass replaced. The trustees held a successful spring work day. A punch list for the manse is being compiled and addressed (paint, roof, etc.). The new landscaping company is having some transitional challenges, but trustees are working with them to understand the needs and expectations.

Board of Trustees Financial Summary

We are in the black at this time and YTD general fund has an increased 9%.

Take action on the recommendations from the Trustees

Last month, the trustees recommended that session approve and proceed with the purchase of an AED and an upgraded First Aid Kit and explore hosting a CPR training course at Fairview. In addition, it is recommended to conduct the security table top drill. Don Titus also suggested we ask for police surveillance during worship. Trustees also recommend doors be installed between the foyer and the

hallway. Trustees are looking to session to approve recommendations and move the project forward.

Elder Adler suggests establishing a security committee consisting of at least 2 elders and 2 trustees who will facilitate these specific actions and coordinate the follow up activities such as procurement of recommended items, training, table drill, facilities changes, and ongoing procedural changes. Emergency preparedness may need to look at renewing the training and certifications around working with children.

Elder Baxter will look into the insurance related to liability for any plans that FEPC establishes.

Motion to approve that Trustees establish a security committee, purchase AED, procure first aid kit, conduct security table top drill, get recommendations for facilities improvements and determine insurance/liability of our decided upon action plan by Elder Adler. Seconded by Elder Baxter. Approved unanimously. Elder Baxter and Elder Adler will represent session on such a committee.

Update // Congregational Care - D. of Min. Lesher

D. of Min. Lesher and Joyce Lesher visited Tel Hai April 26^{th.} They met with Dorothy Greeby and Adrienne Karr and shared communion. Lesher also met with Frieda Mecray. Sharon Cumming would like to meet with D. of Min. Lesher to discuss joining the church. Conversation regarding caring for the flock pursued and Session believes personal check ins will be an effective means to keep connected. **Elder Gyrath recommends that the church office send a church bulletin to the shut ins each week.** The recommendation to include a brief hand-written note along with them would be a nice touch.

Event // Update Men's Retreat Saturday "Avoiding Shipwreck; Finishing Well" – D. of Min. Lesher

We are planning for a one-day event to be held at Fairview on October 13. The facilitator will be Rev. Bob Reid from Lancaster Bible College The topic will be "Avoiding Shipwreck; Finishing Well" and is based upon 1 Timothy 1:18-19. Continued planning will pursue.

Update // Proposed Outreach Initiative – D. of Min. Lesher

Elder Baxter attended the Deacon's meeting and brought forth our concerns for a list of members who have not been in worship attendance this year. For all but two, the deacons have communicated with and are aware of challenges said members are

facing. Upon review of list, it is agreed that an outreach letter should be sent to the Swenson family (non-members but church "friends") and member Laura Yingst.

Event // Church Picnic, Sunday June 10 – Resting Elder Thompson

Elder Ludt is to create a flyer for the band event. The church office will print on cardstock and send a handful to each Windsor, Alliance and Glenmoore Methodist. A sign will be posted outside. Resting Elder Thompson to speak with Val Petrie about using their hay wagon as a stage for the musicians. RE Thompson requested approval to pay for the grilled meats. Motion to approve by Elder Adler. Seconded by Elder Gyrath. Approved unanimously.

Update // Recreation Night: Community Volleyball - D. of Min. Lesher & All

The volleyball net has been set up and tested for use. There is a sign up on the welcome desk. Flyers could be made up and shared at the church picnic.

Update // Senior Recognition Sunday June 3 – D. of Min. Lesher

Each graduate will receive a *Jesus Calling for Graduates* book. Graduates include Patrick Finch, Ronald Finch, CJ Shaffer, Diana Sears, Ross Obenschain, Zach Kinkelaar, Alex Kinkelaar and Spencer Kinkelaar.

Proposed Event // Fightin' Phils Faith Night (July 22)

Sign up needs to be complete by mid June so tickets can be arranged. Game and buffet is \$28 if you have 20+ people. The cost is \$29 if less than a group of 20. D. of Min. Lesher recommends a scholarship if cost is prohibitive. Session indicated that the Pastor's Discretionary Fund can be used for such items.

Called Congregational Meeting // Sunday, June 10 positions – Dir. of Min. Lesher & All

Meeting to be held following worship to present nominees for church leadership. Clerk for the meeting will be D. of Min. Lesher. Moderator for the meeting will be Elder Adler.

Dates for New Officer Training Sessions // - Dir. of Min. Lesher & All

D. of Min. Lesher will offer two dates for training. Sunday, July 8 or Wednesday, July 11

Installation/Ordination Service is scheduled for Sunday, August 19. Elder Mecaughey recommends Ron DiNunzio be present for installing/ordaining.

Renew/review D. of Min. Lesher's covenant agreement (6 month covenant comes due the end of June) – Elder Mecaughey

Elder Mecaughey communicated with D. of Min. Lesher and reported that fulfilling this role has been immensely satisfying to him. Discussion by session members reaffirmed our appreciation and satisfaction with all that he is doing in this role. As the personnel representative, Elder Mecaughey proposes to extend his covenant for another six months. Upon additional discussion, session would like to extend beyond six months to be sure that he could aptly prepare for the Advent season without being in transition. Discussions ensued to validate that the current terms still work for both sides of the agreement. Elder Ludt motioned to renew the Ministry Director Covenant for 12 months. Seconded by Elder Adler. Approved unanimously. Elder Mecaughey will announce this from the pulpit during the Called Congregational Meeting June 10th.

Called Congregational Meeting Minutes

Sunday, June 10, 2018

On the above date, a Called Congregational Meeting was held at the church following the morning worship service. Approximately 50 persons were in attendance, and with the quorum being satisfied, Elder Roy Adler, who served as Moderator, called the meeting to order at 11:45 am.

Elder Adler called upon Dir. of Ministry Dennis Lesher for the opening prayer.

Elder Adler informed the congregation that the purpose of the meeting was to present the slate of names for approval by the congregation to the various church leadership positions. Following a training session later this summer for these persons, an installation service and ordination, (if needed), will occur during the August 19, 2018 morning worship service.

Elder Adler called upon Elder Bonnie Mecaughey for the presentation of Nominees.

Prior to listing the nominations for the various offices, Elder Mecaughey informed the congregation that the Session took action to extend the covenant with Dennis Lesher, Director of Ministry. 
Since this was the only official business brought before the congregation for approval, Elder Adler called upon Dir. of Ministry Lesher to close the meeting with prayer.

One Key Reason Most Churches Do Not Exceed 350 in Average Attendance

Nine out of ten.

That's a lot.

Nine out of ten churches in America have an average worship attendance of less than 350. And that percentage has not changed significantly for many years. Yet the unchurched pool of persons is increasing in most communities. There are people yet to be reached.

But most churches will never exceed 350 in attendance. Why?

A Few Caveats

Allow me to preface my analysis. First, big is not necessarily better. A church with more people in attendance is not necessarily more faithful than a smaller

church. Second, some churches are in very sparsely populated areas. There may not be 350 people in a five-mile radius (though every community still has people who need to be reached).

My third caveat is key. I believe leadership is indeed a biblical and theological issue. It's really a matter of healthy stewardship. I offer this third caveat because I will be addressing the issue of leadership in this post.

Attendance Levels of Churches in America

We are a nation and continent of smaller churches. And though we have far more small churches than large churches, there is a big migration of people from smaller to larger churches. In other words, many of the smaller churches are getting smaller, and many of the larger churches are getting larger.

Here is a simple depiction of the number of churches at three different levels:

- 50% of all churches in America average less than 100 in worship attendance.
- 40% of all churches in America average between 100 and 350 in attendance.
- 10% of all churches in America average more than 350 in attendance.

Keep in mind that the upper 10% tend to include more of the growing churches, while the lower 90% tend to include more of the declining churches.

One of the Key Reasons

There is no single reason to explain the apparent ceiling of 350 in attendance of most churches. I do believe, however, that there is a major reason for this barrier. Such is the thesis of this post:

One of the key reasons most churches do not move beyond 350 in

average worship attendance is they do not have sufficient leadership and structures in place.

Many smart people have provided analyses of what is commonly known as the 200 barrier. I believe that the 200 barrier is highly elastic. In other words, the barrier is really somewhere between 150 and 350, depending on a number of circumstances. Again, I believe that the key reason stated above is among the greatest inhibitors of growth.

Increasing Organizational Complexity

Moses was an unintended victim of organizational complexity. He was trying the Lone Ranger approach to the leadership of Israel. The nation would implode and he would lose his leadership authority if he kept doing what he was doing.

His father-in-law, Jethro, saw the flaws of his leadership and said:

"What you're doing is not good . . . You will certainly wear out both yourself and these people who are with you, because the task is too heavy for you. You can't do it alone" (Exodus 18:17-18, HCSB).

So, following Jethro's advice and wisdom, Moses became a different kind of leader with a different kind of organization.

Here are the five major levels of organizational complexity in churches according to average worship attendance:

1. Under 100: Family and friends

2. 100 to 250: Basic

3. 251 to 350: Challenging

4. 351 to 750: Complex

5. Above 750: Highly complex

Most churches cannot or are not willing to make the types of changes that are necessary in complex organizations. In future resources, I will share what many leaders and churches are doing to move beyond the 100, 250, and 350 ceilings. In the meantime, let me hear from you.

Commentary:

- 1. May GF income had an unfavorable variance of \$5.6K against the budget (Box C). YTD GF income received toward YTD budget is 81%. Over the same period in 2017, income:budget was 87%.
- 2. May GF expenses had a favorable variance of \$4.7K against the budget (Box I). Note: Pastor salary, adminstration, and facilities account for nearly all of May's favorable variance.
- 3. YTD GF income exceeds GF expenses by \$11.2K (Box O), a favorable variance.
- 4. The General Fund balance increased to \$44,843 (Box Q), a YTD increase of 33%.
